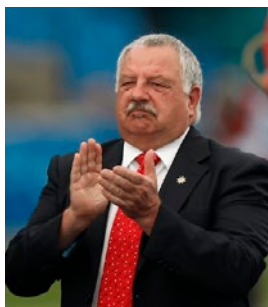

2021 BOARD CHAIR'S REPORT

Barry Dent



I present my Report for the year ended 31 December 2021.

2021 was another year affected by the world-wide pandemic. We expected to be in a better position, but a consequence of living through a pandemic was that a lot of things change and change very quickly. Again this year we have weathered the change environment well and the future appears bright. There is no doubt 'change' will continue to impact us and we will need to be nimble enough to take advantage of all the opportunities that present themselves.

OUR PEOPLE:

Our long-time Patron, **Maurie Henshall**, passed away on 11 October 2021. Thanks to Maurie for all the wise counsel so freely given over many years. Rest in peace Maurie. **Lisa Davison's** two terms on the Board came to an end at last year's Annual General Meeting. My thanks to Lisa for her commitment to the game of basketball over six years. Thank you! Last year's Annual General Meeting confirmed, after the appointment process, the appointment of **Barry Dent** for a further term of three years and the election of **Alan Wenmoth** unopposed for the same term. As there were insufficient nominations for elected Board Members a vacancy existed and **Jane Lattimore** was co-opted to the Board on 06 July until the 2022 AGM. **Ben Sheat** resigned from the Board on 15 February 2022 and this vacancy will be filled in accordance with the appointments process.

Clive Beaumont completed his second year with us as General Manager in December. Clive has already made his mark at a BBNZ level and his leadership of

the operational side of Canterbury basketball has been outstanding. **Lori McDaniel** resigned to take up a position as a BBNZ Community Lead during the year. Whilst Lori will no longer operate from the same office as the CBA her passion for the game of basketball will certainly not be lost to us. **Jozsef Molnar** and **Rebecca Moon** resigned to pursue other employment during the year. All the best to them!

STRATEGIC PLAN:

Our Strategic Plan for the period to the end of 2022 remains unchanged. The Plan, containing the Strategic Goals and the Outcomes is published on our web site so all participants can be aware of its contents.

The Plan sets out four areas in particular to achieve. They are to be resilient, adaptable, to be growing and to be vibrant. It is fair to say that this Strategic Plan is a significant challenge for us to achieve. The Board makes no apologies for this.

The General Manager has developed an Annual Operational Plan based on the Strategic Plan and this was updated near the end of 2021. Progress is being made to achieve the various aspects of the Strategic Plan but COVID has put the brakes on a number of the outcomes in 2021. Clive reports to the Board each meeting on achieving the contents of this Operational Plan.

ALLOYFOLD CANTERBURY WILDCATS:

The Wildcats were a very important step in the pathway for Canterbury women and a great branding opportunity for the future. The 2021 season saw the continuation of a very different Women's National

Basketball League competition because of COVID-19. The tournament was to be held entirely in Auckland with the Women's National League picking up a significant proportion of the costs. The Wildcats were on top of the competition ladder after two rounds, but unfortunately that was the end of the 2021 competition. The Women's National 3x3 did not proceed.

Sadly whilst we were giving it our all, behind the scenes work was underway to develop a new Women's National Basketball League. Though the Canterbury Basketball Consortium we led made a carefully targeted submission for a Franchise, we were unsuccessful. Effectively the Wildcats team and the CBA brand that had been built over nearly forty years were destroyed. Sadly the vision being promoted that Associations are not in a position to run teams in professional leagues won over. It is disappointing, when you believe you have a well organised proposition, that politics play a far greater part in the decision-making process than they should.

KEY PARTNERSHIPS AND COLLABORATION:

In order to achieve the outcomes set out in the Strategic Plan we need to work alongside a number of other organisations. Those we work alongside include our local Clubs, Basketball New Zealand (BBNZ), Canterbury Regional Basketball Foundation (CRBF), North Canterbury Basketball, Mid Canterbury Basketball, Sport Canterbury, and School Sport Canterbury.

OUR FINANCES:

A review of the Annual Finance Report shows our financial position remains very sound despite the COVID-19 pandemic. Our surplus for the 2021 year, of \$123,000 is larger than 2020 and our net asset value has increased, to \$524,000, as a result of this surplus.

The Board has set out in the Annual Operational Plan a requirement to utilise our Charitable Status to assist in diversifying our income sources with more vigour going forward.

An area of satisfaction to the Board is the level of reserves held by the CBA. At year's end our reserves have been maintained at over 50% of one year's income.

During the year due diligence was carried out to review the way we invest our reserves given the current low term deposit rates and increasing inflation, which reduces the real value of the reserves over time. After this due diligence process Mark Sheehan Financial was appointed to invest up to \$300,000 of our reserves in a managed Consilium SRI Portfolio.

OTHER MATTERS:

This year saw the first year of the Representative programme returning to being run in-house. Whilst not everything was perfect most participants were very happy with the programme and the results at national tournaments were outstanding.

The BBNZ 'Strengthen and Adapt' Review was implemented in late 2021. The appointment of two Community Leads in Canterbury puts the game in a great space going forward. The CBA is committed to being responsible for part of these salary costs, with a payment of \$21,000 in 2022 increasing to \$36,000 from 2025. We are delighted to be working in collaboration with the Mid and North Canterbury Associations on this.

HAPPY 50TH BIRTHDAY:

The CBA will be 50 years old in August this year. The Board will be looking to celebrate our fiftieth birthday in a fitting manner to recognise this.

THE FUTURE:

Given a number of developments over the last year, the time is right to now be able to put more back into the sport at little or no cost to our participants. The General Manager will outline these exciting developments in his section of this Report and at the AGM.

THANKS!

There are many people who give their time voluntarily to enhance the sport of basketball in Canterbury. The Board thanks you for the time you give to our sport. Thanks!

Thank you to the team at the office, Ben, James, Nicky, Toni, Nicole and Clive for your efforts for the betterment of basketball. Your ongoing commitment is very much appreciated!

Thank you also to our supporters, funding partners and sponsors who assisted us during the year. Without you we would not be able to provide the community with the opportunities they currently have. A list of our sponsors, partners and supporters is set out elsewhere in this Report.

GENERAL MANAGER'S REPORT

Clive Beaumont

So much for my comments last year about the challenges of 2020 and that hopefully 2021 would be a normal year, nothing of the sort and if anything, a lock down at the end of the season posed more challenges than delaying a start of a season.



I am proud of the team at CBA though and their willingness to respond to the ever-changing demands of running a major sport with COVID in our community. It seems 2022 will be similar as we negotiate a way through the Traffic light settings, the differentiation between school and community basketball and the limitations mandated by our venues... or maybe it will all go back to normal before the end of April!

Of course, COVID is no excuse for not striving to be the best and now I have been here for over two years I would emphasise that despite some issues, we do have the best basketball system and competitions in the country and the basketball community we have here in Canterbury is envied elsewhere. This is down to the level of commitment by everyone in our Clubs and schools who have a passion for our Sport and are determined to give the best experience for those that wish to play at whatever level. I acknowledge and thank all those individuals and organisations who support the work of the Association and Clubs. The coaches, administrators, referees, funding organisations, sponsors, and players are all partners on the journey, and integral to the success of the sport in the region.

I do acknowledge the shortcomings we have and I believe that these can be addressed on the short to medium term. The first and most important is the referee situation. We all know that there was a significant struggle to appoint sufficient number and quality of referees in 2021. Whilst part of this was due to the significant 21% increase in teams in the weekend competitions I will not dwell on the reasons but rather the solutions. The

plan we have for 2022 is a short-term plan to fix the number of referees required. We announced this across the summer and have received a mixed response from clubs but others have started to realise there may be a benefit to this. By collaborating in 2022 we can address some of the issues. We have, in January, appointed Toni Smith-Hunwick to the role of Appointments and Development Officer and she will work with clubs and schools to assist clubs in implementing the plan and the implementation of a much more efficient online Appointment system – REFBOOK – will make it simpler and easier, hopefully, to carry out this onerous task each week.

The CBA Club Competition and Club Development plan will be front and centre. We move into our final year of the current strategic plan and, whilst some interruption has been caused, I believe we have made significant strides towards achieving the realistic goals.

I indicated that change at BBNZ was imminent last year with the adoption of the Strengthen and Adapt Plan. As you all now know we have had two Community Leads put in position by BBNZ and the second of which is very much a regional initiative to grow the Women and Girls' space. These appointments sit well with our Club development plan and the Community Leads will be a constant presence in Clubs to roll out and implement plans around increasing Club capability. As Clubs so develop they will become the Hubs for basketball across the CBA Association, naturally leading to links with schools and other providers in the sport. It is clear to me that this plan will address some of the issues we have as an association in terms of Club Development,

as it significantly increases our resources in terms of delivery into clubs.

Over the next three years this initiative will lead to significant progress in terms of Club Development, with consistent and aligned Coach Education, Referee training and upskilling Development Officers to train and accredit volunteers within their clubs. Some of you will recall me talking about the creation of an App for Coaching sessions to be prepared easily and with demonstrations. Without stealing the Thunder of BBNZ too much this is likely to be with us in the next 2-3 months, providing a resource which will make training sessions so much simpler for coaches to plan.

Locally, I continue to challenge the team as to how we at CBA can enhance basketball, by adding value into the clubs and rolling out a raft of development programmes with regards to Club Capability, Coach Education and Mentoring, Referee Development across all levels of the game. The BBNZ Community leads may well become the faces of Club Development but they are working in conjunction with our team and co-ordinating development plans through the steering group. They will be supported by the CBA team to implement the plans within Clubs.

A special thanks to all the CBA staff this year for their contribution and efforts in a challenging year. The CBA office operate as a genuine team and share a common vision for the future of the sport in Canterbury and New Zealand. I would like to acknowledge the contribution of Lori, Rebecca and Jozsef who have moved on, but I see particularly Lori's transition into the Community Lead position as enhancing our Basketball community.



We have been fortunate to recruit Ben Constable who adds drive and energy to the team and as we all know has a true passion for the game.

The CBA Board, who give generously of their time and expertise, should be given the credit they deserve in another difficult year. All Board members contribute and ensure that CBA are properly governed with financial and other risk assessment, as well as ensuring we do not deviate too far from the goals set out in our Strategic Plan.

It would be remiss of me not to mention the Player Development Programme. After an absence of six years in which CRBF looked after the Rep Programme it was decided that this should return to the management of CBA. A decision reached after careful consideration. Our Primary goal was to try to reduce the cost to participants as a means of then making the programme as open to all as possible. We immediately cut Rep fees by 5% without reducing the scope of the programme. We aim to consolidate this in 2022 and look to reduce costs again in 2023. The team responded well to the challenges this placed upon them, a special mention to Lori for her dedication to the programme in 2021. Of course, the reward was that we won three National Championships in 2021 and also had one second-place finish.

Of course, one matter which will have come to everyone's attention is our surplus for the year. A financial result which has allowed us to look at ways of investing back into the sport, now that the Strategic Goal regarding reserves has been met. We will do this in 2022 by reducing fees for competition entry,

investing in the appointment of the two BBNZ Community lead positions and budgeting significantly for investment into Referee training and development.

Finally, I want to mention the Alloyfold Canterbury Wildcats. In 2021 the Committee and Coach determined that we were putting in place a professional programme with Strength and Conditioning, nutrition, and of course on-court training. In addition we committed to ensure that all players capable of playing did not have barriers preventing them from doing so. Mel Downer led this change and the players responded. We had high hopes before COVID intervened and the venue in Auckland shut down, leaving the Wildcats unbeaten at 2-0. Little did we know that this was to be the final games for the Wildcats in the National League. In early December the teams were disbanded unilaterally by BBNZ, and a bid process for a new franchise put in place. Despite our best attempts to overcome the hurdles placed in front of affiliated associations, controversially, we were replaced by a new franchise in the Women's NBL. I would like to therefore acknowledge the Sponsors who supported the Wildcats over the last six years and the efforts of Murray Kennedy who invested so much time and effort into making the WILDCATS the team we are all so proud of.

I am looking forward to an exciting 2022 season... let's all hope that this time next year the word COVID is far from our thoughts.

OBITUARY MAURIE HENSHALL – CBA PATRON

Maurie passed away on October 11, 2021, peacefully at Burwood Hospital, aged 91 years. Maurie's basketball interests began in Christchurch with the Taxes Club when he worked for Inland Revenue in March 1958. He took on an administration role in the club team, he said it was because 'they needed a treasurer, not because he was a player'. This lasted until about 1980.

Maurie was more suited, by his own admission, to roles as an administrator. He enjoyed volunteering in that role and excelled at it.

Although never really an active referee, he devoted time to the referee space. He became a member of the New Zealand Men's Basketball Referees' Association (NZMBRA), beginning with the NZ Indoor Basketball Referees' Combined Committee from February 1970 to February 1971. Over the years he volunteered for many other roles on the committee including vice-president and then president for the majority of the late 1980's. He had roles as an Area Coordinator of local referees in Canterbury (1986-87), plus on the National Referees' Grading Committee (1989), and as an NBL Evaluator (1998). He also served the NBL by serving the Judicial Committee in the late 90s and early 2000s.

Maurie was also active in the executive affairs of Basketball New Zealand (then known as the New Zealand Basketball Federation). He later became a Life Member of Basketball New Zealand, and also the Canterbury Basketball Officials' Association. He was the second President of NZBF (following Lance Cross) from 1974 – 1980 and also patron.

He volunteered for events including as the Technical Director at the XVI World Games for the Deaf in Christchurch, plus even travelled, at his own cost, to the Olympics in Moscow where he attended the FIBA Congress.

For the Canterbury Basketball Association, Maurie was a Life member and our Patron, with his name appearing on many of our winter club trophies. Maurie was an astute judge of the game. He had a big role in basketball, mostly as a humble volunteer making a big difference behind the scenes. He cheeky smile will be missed.

Rest in peace Maurie, thanks for everything you did for our game and community.

CLUB BASKETBALL REPORT

OVERVIEW

Keeping with the theme from last year, we had another challenging season to finish up in 2021. Aotearoa shifted into lockdown in mid-August, which happened to be the point of our season where we had completed all of our regular season games, and only had the post-season still to be played. Games that were meant to be played on August the 21st, instead had a six-week delay, finally tipping off on September 18.

Because of the significant restrictions on attendance, games had to be played with very limited spectators (if any at all), we decided to utilize the offers of court space from Middleton Grange, St. Andrew's College, and Cashmere High School to play these games in, along with Cowles Stadium. Through volunteers, or the

venues themselves, we were able to live-stream each game for those that could not be there in person.

We had the largest single increase in team numbers since at least 2004, when I began recording winter club teams entries (jumping up from 166 teams in 2019 and 2020, to break the 200-team mark by one). Even if we had the planned 177 entries expected in 2020, the increase would have been the largest year-on-year increase, with the exception of 2014 (introduction of our U15 grades), and 2018 (introduction of the BU13 grade).

The McDonald's Thomson and Whelan competitions had 44 teams enter (which matched the 2020 numbers). We again had the Division I and II finals split over

two nights, but with a restriction on the number of people allowed into Cowles Stadium the live stream we provided was the primary way people got to follow their team.

I personally feel very happy that we were able to conclude the season for all of our respective competitions, with each of the clubs and teams involved being very adaptable to the changes we had to enact in order to get the games played.

Once again, I would like to thank all the administrators and coaches I deal with, the work many of you do as volunteers is so vital for what we are able to achieve as a sport, and I'm hopeful that the 2022 season is a return to operating under more "normal" circumstances.

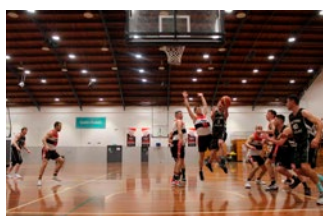

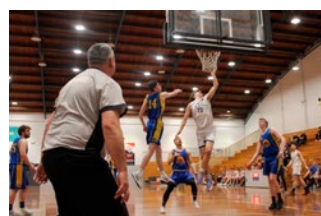

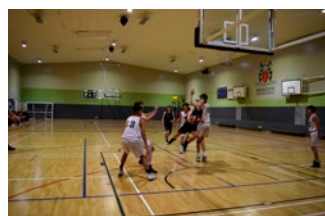

The use of the OwnUrGoal Athlete Monitoring System was also crucial in checking athlete wellness, and load to ensure athletes were injury free and at peak fitness by the start of the tournament. By keeping a close on athletes and how they were tracking,

the Performance Team were able to be proactive in foreseeing potential issues and making adjustments accordingly before they occurred.

We also knew that to be successful we needed to improve in key skill areas such as shooting capacity from range at pace and under pressure, weak hand skill abilities at pace and under pressure, and decision making. Athletes committed to weekly skills sessions 1-2 times a week in the lead up to the competition, on top of twice weekly team trainings. The Celebration Church were kind enough to allow us to utilize their facility and we thank them for their support.

A key partnership was also formed with Lincoln University and the Canterbury Basketball Association whereby I was contracted to lead the LU Women's Program in conjunction with the Canterbury Wildcats Head Coach role. This provided many benefits to all parties, but none more important than to the athletes themselves. With four of our athletes holding Sport Scholarships at LU, this partnership allowed capacity to streamline the development of the athletes by incorporating Wildcats Style of Play concepts into the LU team and skills sessions and as well as increased capacity to monitor athlete load. Thank you to LU for your support of the athletes and the Canterbury Wildcats.

The retention of core athletes and recruitment of players in key areas was a going to be crucial to our success. We set about securing the services of Canterbury favourites and Tall Ferns Tessa Boagni and Lauryn Hippolite whilst retaining key pieces such as Britt Richards, Gemma Etheredge, Rosalia Samia, Tiana Placid and

Millie Knight. We welcomed the return of Wildcat regulars Sapphire Wairau and Terai Elia (nee Sadler) and added scoring power with Hannah Mischewski and Nicole Gleason as well as length and toughness with Nicole Cutler and Emma Trollove.

We asked a lot of the athletes in regards to preparation and professionalism; by including weekly skills sessions and S&C sessions this tripled the commitment required to be a part of the program as well as asking them to provide us with data daily on how they were feeling and what they were doing. We set the bar high and demanded excellence and that is certainly what they gave. I can't thank the athletes and staff for their commitment to the program and the expectations we set as a group striving for success.

The culmination of 4 months of hard work all paid off in Round 1 of the Sal's NBL with two outstanding wins against defending champions Harbour Breeze (75 – 70 in overtime) and Auckland Dream (78 – 58). If you didn't see the games live on TV, do yourself a favour and watch the last 5 minutes of regular time and the overtime period of the Harbour Breeze game for some pretty basketball. Tessa Boagni was outstanding in her return to the court after the birth of her son Noah with 34 points and 21 rebounds as well as hitting the 3 to take the game into overtime. Our high fitness level came into play in the second game against the Dream and we knew that if we kept running and pushing the ball hard that they would not be able to keep up with our pace. We were relentless in transition, sprinting lanes and forcing the Dream to run with us whilst also applying full court



defensive pressure on the other side of the ball, eventually wearing them down and breaking their backs to come out convincing winners. Tessa Boagni was again outstanding, backing up her game 1 performance with an admirable 27 points and 11 rebounds game and was ably supported by Nicole Gleason (12pts, 4 rbs) and Hannah Mischewski (15 points).

Unfortunately, Round 1 is where it all ended for the Sal's NBL tournament. The Delta variant of COVID19 decided to rear its ugly head, forcing Auckland into lockdown and the eventual cancellation of the competition. It's unfortunate for all the athletes, coaches, support staff, organisations, sponsors and fans that the season was unable to finish, however we fully understand and agree that the health and safety of all involved is paramount and thank the League for all of their efforts.

The cancellation of the 2021 season brought about the end of my tenure as Head Coach of the Canterbury Wildcats, with my family moving to Napier at the end of 2021 for my husband to take on the Head Coach role of the Taylor Hawks in the men's NBL. I have been extremely lucky, proud and honoured to have had the opportunity to lead the Alloyfold Canterbury Wildcats over the 2020 and 2021 seasons. I can't thank Murray Kennedy, Clive Beaumont and Barry Dent enough for their faith in me and unwavering support during my time, it has been an absolute pleasure to work with you all and I am eternally grateful for each of you. To the staff who dedicated hours of their time to the team and to me – Helen Williamson, Kylie Cox, Hayden Hall, Jacob Martin, Mindy Morrison, Georgia Woollett and Brady Walmsley – the athletes and I appreciate you more

than we can say. To all the athletes – thank you for coming on this crazy journey with me and for believing in what we were trying to achieve, I am humbled by your dedication and commitment to me, to the cause, to each other and to yourselves. And to the fans – thank you for your support throughout what has been a weird and testing last two seasons impacted by COVID19 – whilst not having the opportunity to play a game in front of a home crowd at Cowles Stadium your presence and support has always been felt and is appreciated.

And lastly - thank you to the greater Canterbury basketball community for welcoming my family and I into the fold, we have enjoyed our time in Christchurch getting to know you all and look forward to seeing you in a basketball stadium in the near future.

2021 saw a tough year in terms of shortages in referee availability. Whatever the reasons behind this it was hard work to try and get all games covered and we acknowledge the need to do better.

Halfway through the season, and after being injured and off work for 6 weeks, we farewellled Rebecca Moon as she departed from her role as CBA Referee Manager. We thank Rebecca for the work that she has done in Canterbury, and will continue to do for the refereeing community in Otago.



1. STATEMENT OF ACCOUNTING POLICIES

Reporting Entity

Canterbury Basketball Association Incorporated is an incorporated society under the Incorporated Societies Act 1908 and is also registered with the Charities Commission as a charitable entity under the Charities Act 2005.

Principal Activity

The Association is primarily engaged in the business of administering amateur basketball at all levels of the sport in the greater Christchurch region.

The nature of the Association's business has not changed during the year.

Measurement Base

These financial statements are Special Purpose financial statements.

Changes in Accounting Policies

There have been no changes in accounting policies this year. All policies have been applied on bases consistent with those adopted in previous years.

Specific Accounting Policies

In the preparation of these financial statements the following specific accounting policies that materially affect the measurement of financial performance and financial position have been applied:

(a) Goods & Services Tax

These financial statements have been prepared on a GST Exclusive basis, with the exception of accounts receivable and accounts payable which are shown inclusive of GST.

GST is accounted for on a "Payments" basis on a two-monthly reporting cycle.

(b) Inventory

Stock on hand is valued at the lower of cost or net realisable value.

(c) Income Tax

No provision for Income Tax has been made as the Association is registered for charitable purposes. All income derived by the Association is exempt pursuant to Section CW41 of the Income Tax Act 2007.

(d) Bank Account Balances

The bank account balances include any unpresented cheques and uncleared deposits at balance date.

(e) Accounts Receivable

Receivables are stated at their estimated realisable value. All receivables are due within 12 months of balance date.

Bad Debts are written off in the year in which they are identified as irrecoverable.

(f) Accounts Payable

All payables are expected to be settled within 12 months of balance date.

(g) Fixed Assets and Depreciation

The Association has the following classes of Basketball and Office Equipment:

Class	Depreciation Rate	Method
Basketball Equipment	20-67%	DV
Office Equipment	16-67%	DV

All Basketball and Office Equipment are recorded at cost less accumulated depreciation.

Depreciation of the assets has been calculated in accordance with the maximum rates permitted under the Income Tax Act 2007. The actual rates used are pronounced on the attached Schedule of Fixed Assets and Depreciation.

Derecognition

An item of Plant and Equipment is derecognised upon disposal or when no further future economic benefits are expected from its use or disposal.

(h) Revenue

Entry and Registration Fees collected are accounted for on an accrual basis.

Donations Received are accounted for on a cash basis.

Grants Income is amortised over the term of the agreement, once all obligations pertaining to the advances have been fulfilled. The unexpired portion of any Grants Income at balance date is classified as Revenue in Advance and included in the Statement of Financial Position under Current Liabilities.

Interest Income is recognised when the deposit or investment has matured and the interest is accrued against the deposit or paid directly into the bank current account.

(i) Operating Leases

Leases under which all of the risks and benefits of ownership are effectively retained by the lessor are classified as operating leases. Operating lease payments are charged as an expense in the Statement of Financial Performance in the periods under which they are incurred.

(j) Investment

Consilium Portfolio is recorded at market value.

5. SECURITIES AND GUARANTEES
