It is both an honour and a privilege to present my first and final report as the Board Chair of the Canterbury Basketball Association, covering the year ending 31st December 2024. This report marks the conclusion of my two terms on the board.

OUR PEOPLE:

2024 saw some changes in our board's composition. We filled three key vacancies following the completion of two terms by Barry Dent, our outgoing Chair, and Alan Wenmoth, as well back-filling a position after the resignation of Greg Williamson in July 2023.

James Pullar was appointed to the open position, while Miranda Gray and Adam Buckby were elected to the two available positions. These new members, together with returning board members Letitia Stenberg, Jane Lattimore, and Will Lovell, have brought fresh energy and perspectives to the team. Their complementary skills and shared vision for a thriving basketball community in Ōtautahi have been invaluable. Together, we remain committed to advancing the strategic goals of Canterbury Basketball.

STRATEGIC PLAN:

The 2023-2027 Strategic Plan. A 2022 post-season survey and stakeholder workshops, highlighted our key strengths:

- Strong membership growth
- Robust representative programs
- Effective player development initiatives

At the same time, the process identified areas for improvement, particularly in:

- Referee development
- Communication strategies

Our recent post-season survey revealed that 100% of administrators, coaches, and managers were satisfied (or better) with our communication. As our membership continues to grow, we are excited to implement new initiatives to further enhance the experience for everyone involved—from players and supporters to referees, coaches, managers, and volunteers. Our General Manager will provide a detailed update on the progress of these initiatives.

OUR FINANCES:

2024 was a financially tight year for many, but our annual finance statement shows an operational surplus of over \$32,000, with an unrealized investment income of \$12,338 from the Consillium Portfolio. While this was a decrease from the previous year, we are pleased with our fiscal health. Please refer to the attached 2024 Annual Finance Report for more details.

MOVING FORWARD:

Over the past six years I have served on the CBA Board, and with over 30 years of experience in club basketball, it has been a privilege to witness the sport's growth from various perspectives—whether as a player, parent, coach, manager, or administrator. I am deeply grateful for the guidance of past leaders and the opportunity to contribute to our collective success.

Throughout my time on the board, we have faced many challenges, but we have consistently improved and capitalized on basketball's global popularity. Our membership continues to grow, and our processes are evolving to meet these needs.

As my tenure concludes, I am confident that CBA is on the right path to meet the needs of our community, in line with our strategic plan.



However, we cannot do this alone. And finally, a heartfelt thanks to anyone else who contributes in ways I may not have mentioned. We are truly grateful for all of you.

GENERAL MANAGER'S REPORT

2024 saw the commencement of new programmes and initiatives to encourage greater participation across the community creating opportunities for those wishing to play (an adaptive format) and thereby enriching our community further by giving them access to the sport. The appointment of our new Diversity and Inclusion Development Officer ensured that these areas, as well as early female participation will have a key focus moving forward as set out in the Strategic Plan. A key factor in ensuring the longevity and sustainability of these programmes will be collaboration across our community, as we move forward in developing them into a permanent fixture in our calendar.

Other highlights were the emergence of Walking Basketball being enjoyed by older ex-players and their whānau as well as others in the community; the increase in Primary School teams/players showing the next generation is there to continue this amazing growth in the sport; our development courses for referees and coaches alike; the Coach Connection Forum; and of course our weekend and premier High School competitions. Of course, our Player Development programme continues to thrive with two further National Championships won at Under 20 level. Within the Rep programme we have made significant progress in Coach Development with 72 coaches now applying to be involved. The advent of the Apprentice coach system, assigning developing coaches to learn from experienced Head Coaches has had significant

effect and we will, moving forward, seek to refer these coaches back to clubs and schools to hone their skills, but also provide a coaching workforce organically within the community.

We, at CBA, all strive to be the best and despite some issues, we do have the best basketball system and competitions in the country, and the basketball community we have here in Canterbury is envied elsewhere. We always need to bear this in mind to put some perspective on matters.

Our prudent and sound financial management has led us to be in the desired position of maintaining a healthy level of reserves. This gives us good financial stability which would allow us to retain capacity and capability, should another event occur which leads to a period where revenues of any nature dry up unexpectedly. Although our operating surplus is down this year, and a significant amount stems from interest and investment return, it reflects the need to operate year-by-year from revenue generated and we strive to do this as best we can. At the end of the year clubs were notified that fees would rise in 2025 but we have ensured it is by only what is necessary and still leaves us effectively running programmes at the same cost level to participants as we did in 2021, despite the rising associated costs.

I hope 2025 sees the formal adoption of the Tier One/Tier Two Association delivery system,





which consequently should see a robust aligned implementation and development plan from BBNZ, which CBA will utilise to develop our people – coaches, referees, and volunteers - cementing our place as the leading association for Player, Coach, and Referee Development. As we are confirmed in 2025 as a Tier One Association we will continue to work with Lori and Liz to progress projects in terms of Club Development, consistent and aligned Coach Education, Referee training, and upskilling Development Officers to train and accredit volunteers within their clubs.

Coachmate is a game changer as far as the volunteer coaching force is concerned. It is a great tool for coaching sessions to be planned easily, and as well as the team management tool in 2025 there will emerge further drills and coaching ideas. I urge all clubs to ensure their club coaches are aware of this tool and adopt the use of the same. Unsurprisingly we have been informed that Canterbury already is the leading association in terms of sign up for the use of Coachmate.

I am proud of the team here at CBA and their willingness to respond to the ever-changing demands of running a major sport in our community. The hours they dedicate to making basketball an enjoyable participation and competitive experience cannot be underestimated, so I extend a special thanks to all the CBA staff this year for their contribution and

efforts throughout the year. The CBA office operate as a genuine team and share a common vision for the future of the sport in Canterbury and New Zealand.

The CBA Board, who generously give their time and expertise, should be given the credit they deserve. New Board members have joined the governance body and contributed fully in 2024 to ensure that CBA are properly governed with financial and other risk assessment, as well as ensuring we do not deviate too far from the goals set out in our Strategic Plan.

I have said before and repeat it again – that they level of commitment from club volunteers and officials to give the best experience for those that wish to play at whatever level, is truly inspiring and personally is what motivates me. I acknowledge and thank all those individuals and organisations who support the work of the Association and its Clubs. The coaches, administrators, referees, funding organisations, sponsors, and players are all partners on the journey, and integral to the success of the sport in the region.

I can only finish by saying thank you to all in the sport as your collective contribution, I believe, made 2024 an outstanding year for basketball in Canterbury

CLUB BASKETBALL REPORT

OVERVIEW

We were forced again to cap the number of male teams competing in our weekend competitions. This year we had 203 teams in total enter our Saturday and Sunday club grades (compared with 204 in 2023). This was the first time we had a reduction in weekend club team entries since the 2014-2015 seasons. We were fortunate to be able to utilize the new Hickman Gymnasium at Christ's College for eight games each Saturday, and another two-court venue is looking like a strong possibility for us to use in 2025, which may mean we can afford to raise our limit on teams a bit next season.

In 2024, we had a very consistent group of Floor Controllers each weekend, which allowed Sam Strangman and myself to rotate between the ten different venues (using 16 courts in total) we were normally operating on Saturday.

For our boys' Sub grade competitions, we trialed having a mini-playoff structure, with four teams selected to play a semi-final and final. This had great feedback in the B15 and B17 grades, and was a way to have a definitive end to these competitions appealing to teams.

In the High School space, our "Lincoln University Thomson and Whelan Trophy Competitions" had

41 teams competing over Terms Two and Three. Four boys' teams, and four girls' teams, from our competitions qualified for the Secondary School National Tournament. The second season of the NZCT Grocott Cup, had 10 Y9/10 Boys' teams enter in this competition's second season, with seven of these teams then competing in the Junior Premiership (all placing in the top 11, along with Hillmorton lifting both the Canterbury, and South Island, trophies!)

The Cowles Primary School competitions kept the same structure as last year, with four on four competitions run for Miniball (Y3/4) teams, and five on five being run at the Y5/6 and Y7/8 levels. Sam Strangman took over the administration of these competitions, and played a key role in the motivation, and development, of the referees at these competitions.

Each year, I find myself expressing similar sentiments, but my gratitude towards the administrators and coaches I work with remains front and center when I reflect on the season just completed. Your dedication and efforts are the reason basketball thrives across the motu, reaching so many people in various places. I am hopeful that the 2025 season will run smoothly and look forward to fostering an even stronger sense of community in 2026 – when Parakiore is scheduled to be open for community use.

Pioneer's Premier Men's team was back in the Grand Final for the third straight year – facing an extremely motivated Gators team (who last reached the final in 2018).

Despite facing a size disadvantage, Gators' gameplan was focused on the tempo of the game, trying to keep it high, and using lots of off-ball movement to attack the Pioneer defence. Early in the third quarter it seemed like the task may be too big for them, as one of their key players, Josh Nickel, left the game with a serious leg injury.

Pioneer was able to feed League MVP Ben Constable, who only missed two shots en route to 28 points and 12 rebounds against the much smaller Gators' frontline. Gators was able to consistently keep Pioneer at bay with some important baskets.

Louie Gordon's clutch 3-point shot brought the Pacers within two points with :27 remaining, after Seth Bryant's floater extended the Gators' lead to five points immediately beforehand. Finals MVP Zach Hannen's consistent free-throw shooting under pressure was also pivotal in securing the win for the Gators, scoring the final two points for Gators (from his total of 25) in a thrilling 105-101 game, with Pioneer unable to score in the final twenty seconds before time expired.

Overall, it was a game marked by a high level of shot-making and intense defensive plays, showcasing the high level of competition between these two teams, with both teams exchanging leads multiple times.

**WOMEN'S DIVISION ONE:****UNIVERSITY OF CANTERBURY vs HALSWELL (4 TEAMS)**

2024 was the ninth consecutive season that a Halswell team had qualified to play in the Grand Final for the Women's Division One Grade, with the matchup against UC being the fourth straight Grand Final where the two clubs met. In addition to this, the Grand Final was their fourth meeting of the season, with Halswell holding a 2-1 edge here (with all three games decided by double figures). All of the Women's Division I teams played five crossover games against the French Cup teams to give them some extra variety in terms of their opponents this season.

Halswell's normally potent offence, struggled mightily against the UC defence, only amassing a paltry 22, allowing UC to win all four quarters in the game. Kali Zygmant dropped in 13 points, and was named as Finals MVP for the competition.

University of Canterbury successfully reversed 2023's result, winning the 2024 Grand Final 60-22, pushing the alternating championships out to four straight seasons now.

DEVELOPMENT REPORT

COACH DEVELOPMENT

In 2024, the Canterbury Basketball Association (CBA) continued to build on the foundational work established in previous years, further developing coaching programmes like the Coaches Connection Forum and Rep Programme masterclasses, while adding new tools such as the CoachMate App and Apprentice Coach Programmes. These efforts, along with ongoing community coach development events and the progression of coaches within the Mainland and U14 Development Programmes, underscored a commitment to nurturing the established base while testing innovative new initiatives.

Throughout the year, over 50 separate coach development sessions were offered, ranging from introductory courses to masterclasses and interactive sessions, totalling over 700 participations. The expansion of the Signature League programme provided a developmental platform for coaches and coach developers, alongside referees and players, fostering skills in a high-pressure, supportive setting. The Apprentice Coach Programme further enriched the rep and development programme ecosystem, offering hands-on coaching experience. This created a clear pathway for coaches to grow within the basketball community while offering a tool to recruit and develop young coaches. Twenty coaches concluded their apprenticeships within the U14, U16, U18, and U20 programmes, and an additional six within the 3x3 programme. These recruiting efforts culminated in a record number of 74

expressions of interest to coach in the CBA's 2025 programmes.

The introduction of the CoachMate app also marked a positive change in the coach development environment. It was heavily promoted across all primary school club competitions, enhancing the coaching experience at the grassroots level. Basketball New Zealand announced that the Canterbury Basketball Association had the highest usage and download rate of any association for the app, underscoring CBA's commitment to developing coaches, valuing partnerships, and utilizing technology to enhance our community.

REFEREE DEVELOPMENT

2024 marked the second year of CBA's four-year Referee Development Plan. The plan aims to address the need for more trained referees due to the rapidly growing demand at all levels from increased participation. The plan focuses on improving recruitment, retention, and development of community referees, with a four-year goal to enhance the referee pipeline, particularly targeting the junior club grades (level B and C). Key strategies include formalizing recruitment processes, refining retention approaches, and enhancing development pathways through training and mentorship programs.

The Referee Development programs in 2024 saw a series of 39 targeted trainings and workshops, with a total of 484 participants, aimed at elevating the standard of officiating within the association. The year provided a number

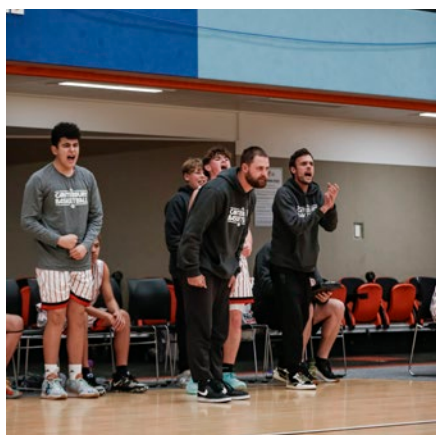
of options for referee skill enhancement, ranging from Level Zero courses to advanced Block/Charge courses led by experts. The continuation of the Whistle Club and Referee Collective supported a community of learning and development among referees, contributing significantly to the overall quality of the game in Canterbury.

The new in-season Referee Accelerated Development Programme, spearheaded by Clive Beaumont, aimed to develop a wider pool of referees for higher grades. This programme provided approximately 40 referees with both on and off-court training and support, accelerating their progression through the Canterbury Basketball Referee Structure and Pathway.

PLAYER DEVELOPMENT

Finally, we would be remiss to not mention the progress within the player development system. The expansion of the Term One and Term Four Signature League, with the support of Signature Homes North, has seen a significant expansion in the breadth and depth of players in our region. This culminated in a record number of teams entering qualifying, national and regional tournaments and BOTH the U20 Men and Women winning the national title, and all representative teams making major national finals.

A big thank you to both Signature Homes North and the outstanding, committed and growing team of coaches we have giving back to our community.



REPRESENTATIVE PROGRAM REPORT

Another year of recording coach and player numbers across all programmes and competitions saw 13 rep teams attending qualifiers, 12 teams attending nationals, 13 Mainland's and nine to the U14 regional tournament. All teams were led by an outstanding team of community coaches and managers who we would like to take the time to thank for an outstanding job.

We would also like to thank Signature Homes North for their continued belief and support in the programme and engagement in the community, particularly the growth of Signature League that provides a programme unique to our community to foster the development of our hundreds of youth players and coaches.

DIVERSITY AND INCLUSION REPORT

Ty Scott

A Year of Growth and Firsts in Diversity & Inclusion

Canterbury Basketball took significant strides in the diversity and inclusion space this year, marking a series of “firsts” in our commitment to making basketball accessible for all. The establishment of the Diversity and Inclusion Development Officer role has enabled new programs and opportunities to be created for participation across all levels.

WĀHINE DEVELOPMENT

Girls Got Game

Our participation objectives in the wāhine space have been ambitious, with the formalization of the **Girls Got Game** program. This year, we strengthened program delivery by onboarding dedicated coaches, maintaining a 10:1 participant-to-coach ratio to ensure high-quality sessions.

The program’s reach has grown significantly from 7 schools in 2022 to 21 in 2024.

We are noting that this expansion has had a direct impact on participation in school competitions:

- **Term 4, 2023:** 5 schools entered all-girls miniball teams, with only 1 of these schools having participated in Girls Got Game.
- **Term 4, 2024:** 11 schools entered girls’ teams – a 120% increase – with 7 of these schools having hosted Girls Got Game sessions.
- **In our Year 5/6 competition,** seven schools entered in both 2023 and 2024. However, in 2024, we introduced Girls Got Game (GGG) into one of these schools, expanding our reach within the competition.
- **For Year 7/8,** participation saw significant growth. In 2023, four schools entered, with GGG delivered in two. By 2024, participation increased by 125% to nine schools, with GGG delivered in four, further strengthening the pathway for girls in basketball.

This data highlights the strong correlation between program outreach and increased

female participation. By engaging with a wider range of schools, we are actively growing the game for young girls in Christchurch, which will have a positive number impact on our sport in years to come.

Wāhine Committee

In order to strengthen club pathways for girls and women, we established the wāhine committee to ensure good, open discussion on developing pathways in clubs for women and girls.

Developing Future Female Coaches

The **Coach Connection Forum** took place in Term 4, with an added focus on supporting female coaches. These sessions provided opportunities for foundation building, networking, and development, as well as, strengthening connections within the coaching community.

A key part of growing the girls’ game is ensuring we have strong female leaders guiding the next generation. This year, we made big strides in coach development, with around 30 people—mostly women—



trained in coaching beginners through the Girls Got Game Coach Development initiative. Additionally, we delivered our first sessions of Boss Ballers, a program designed to equip young women with the skills, confidence, and experience to take on coaching roles. By investing in female coaches, we are not only strengthening pathways for players but also creating more visible role models, ensuring wāhine leadership remains a core part of basketball in Canterbury.

GLOW Fest

Canterbury Basketball brought the South Island's first-ever glow-in-the-dark basketball event to life, creating an electrifying experience designed for girls. The inaugural GLOW event featured two sessions—one exclusively for girls, which sold out with 60 participants, and a mixed-gender session that attracted 30 players. It's success was made possible with the support of Pioneer Basketball Club, North Canterbury Basketball, and BBNZ, whose volunteers played a key role in delivering the experience.

DIVERSITY AND INCLUSION DEVELOPMENT

Wheelchair Basketball for Juniors and Beginners

2024 marked a new era for Canterbury Basketball Association, expanding access to communities previously without basketball opportunities. A key focus has been Junior and Beginner Wheelchair Basketball, with strong participation from both disabled and able-bodied players.

- **Term 1:** 59 total participants on session number (20 with disabilities, 39 without)
- **Term 2:** 91 total participants on session number (35 with disabilities, 56 without)

This pilot has demonstrated the power of inclusion, with able-bodied players actively engaging alongside athletes with disabilities. It highlights Canterbury Basketball's commitment to fostering a truly accessible and inclusive basketball community.

Inclusion League

The newly formed Inclusion League launched in Term 3, creating a competitive

and welcoming space for teenagers with disabilities. Over six weeks, five teams from two high schools, one club, and two community groups took the court, with 32 athletes participating.

The league was built on the principles of 100% participation, ensuring all players had time on the court, enjoyment, prioritizing fun and engagement over competition, and growth & belonging, fostering teamwork and individual development.

A key feature of the league was its weekly value-based awards, where coaches recognized players who embodied core values:

- **Aroha** for compassion and sportsmanship
- **Kotahitanga** for playing with love for the game
- **Manaakitanga** for empathy, understanding, and care
- **Noho Tahi** for creating an inclusive and positive space



With its successful debut, the Inclusion League has set a strong foundation for future growth, proving that basketball truly is for everyone.

Visibility as Disability Activators in the Community

Canterbury Basketball further established itself as a visible leader in the disability space, actively delivering inclusive basketball programs alongside providers such as The Halberg Foundation, Parafed Canterbury, Sport Canterbury and TIMA. By working in partnership with key organizations, we expanded our reach, strengthened support networks, and ensured that basketball continues to be a sport where everyone belongs. In addition, we supported Selwyn Hawks and championed Pioneer's Panthers program. These two clubs did a fantastic job of welcoming and supporting the disabled community, reinforcing: Basketball for All.

Walking Basketball

Walking Basketball provided a fun and inclusive space for the 12+ community and families to play together, reinforcing

basketball as an accessible, multi-generational activity. Pioneer basketball club also delivered in this space. We are able to organise a game to bring the offerings together in an East Vs West match up that embodied the spirit of connection in the games.

Midnight Basketball

Midnight Basketball continued to provide a safe, inclusive space for teenagers to play the game in 2024. As expected with a drop-in-style program, numbers ebbed and flowed throughout the year, with participation averaged to 67 youth in Term 1 and 43 in youth in Term 4 per night across the city. Midnight Basketball remains a key part of Canterbury Basketball's inclusion efforts, reinforcing our commitment to using the game as a tool for community-building and positive youth engagement and we thank Wharenuī Gators for their efforts in partnering with CBA to bring this opportunity to youth on the west side of the city.

Looking Ahead: Growing the Game, Strengthening Our Community

2024 has been a huge year for diversity and inclusion in Canterbury Basketball. We've hit some incredible milestones—from launching the Inclusion League to running the South Island's first-ever glow-in-the-dark basketball event. Girls Got Game has also seen massive growth, helping us get younger wāhine involved and keeping them in the sport.

But this is just the beginning. We're committed to building on this momentum—breaking down barriers, creating more opportunities, and making sure every player, regardless of background or ability, has a place in our basketball community.

A massive thank you to everyone who has been part of this journey—our players, coaches, volunteers, and supporters. Your passion and dedication are what make this all possible.

The future of basketball in Canterbury is bright, and we're just getting started.



REFEREE REPORT

APPOINTMENTS AND OVERVIEW

Once again, a big thank you to all the referees, schools and clubs for their help and encouragement across season 2024. Thanks to the efforts of all in the community, confirmed appointments from clubs/schools and referees for Friday draws being sent out rose to 87% and we had 92 different people referee 10 or more games across the season. The conversation is also beginning to turn to making sure that both Suitability and Availability of Referees are factored into assigning for weekend games, though there is still some work to be done on both fronts.

REFEREE SUPERVISION/TRAINING

We recorded nearly 320 hours of Supervision for the younger grade games over the course of 2024, which equates to about 63% of relevant games (Girls 16U/ Boys 15U and below) covered with multi-court venues again being prioritised. Through the efforts of John Bartlett, Gavin Zimmerman, Toni Smith-Hunwick and Steph Eldred we have also seen 12 more people certified as Level 1 referees.

DEVELOPMENT

Over the course of 2024, we have had 37 courses (as of Sep 2024) aimed at recruiting and developing referees, highlighted by 13 Level 0 courses across the region, 3 Level 1 practical workshops and the further implementation of the Junior Referee Development programme in Term 1 alongside the Signature League action.

REFEREE COLLECTIVE

Thank you once again to the support and help of the Referee Collective for their



leadership, supporting me and giving feedback around the appointments and for their investment in the community. I'm grateful for their efforts and look forward to seeing the referee community continue to be in good hands. A big thanks to the members: Raewyn Willocks, Hamish Dale, Jayden Rosanowski, Sophie Currie, Shane Varga, Paula Wilkinson, Sandra French, and new member Richie Tikolevu Snr.

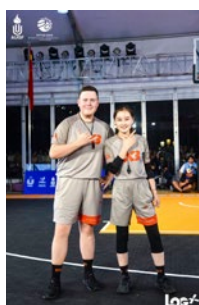

1. STATEMENT OF ACCOUNTING POLICIES

Reporting Entity

Canterbury Basketball Association Incorporated is an incorporated society under the Incorporated Societies Act 1908 and is also registered with the Charities Commission as a charitable entity under the Charities Act 2005.

Principal Activity

The Association is primarily engaged in the business of administering amateur basketball at all levels of the sport in the greater Christchurch region.

The nature of the Association's business has not changed during the year.

Measurement Base

These financial statements are Special Purpose financial statements prepared for the use of the Governing Board and may not be appropriate for other purposes.

Changes in Accounting Policies

There have been no changes in accounting policies this year. All policies have been applied on bases consistent with those adopted in previous years.

Specific Accounting Policies

In the preparation of these financial statements the following specific accounting policies that materially affect the measurement of financial performance and financial position have been applied:

(a) Goods & Services Tax

These financial statements have been prepared on a GST Exclusive basis, with the exception of accounts receivable and accounts payable which are shown inclusive of GST. GST is accounted for on a "Payments" basis on a two-monthly reporting cycle.

(b) Inventory

Stock on hand is valued at the lower of cost or net realisable value.

(c) Income Tax

No provision for Income Tax has been made as the Association is registered for charitable purposes. All income derived by the Association is exempt pursuant to Section CW41 of the Income Tax Act 2007.

(d) Bank Account Balances

The bank account balances include any uncleared deposits at balance date.

(e) Accounts Receivable

Receivables are stated at their estimated realisable value. All receivables are due within 12 months of balance date.

Bad Debts are written off in the year in which they are identified as irrecoverable.

(f) Accounts Payable

All payables are expected to be settled within 12 months of balance date.

(g) Fixed Assets and Depreciation

The Association has the following classes of Basketball and Office Equipment:

Class	Depreciation Rate	Method
Basketball Equipment	21.6-67%	DV
Office Equipment	16-67%	DV

All Basketball and Office Equipment are recorded at cost less accumulated depreciation.

Depreciation of the assets has been calculated in accordance with the maximum rates permitted under the Income Tax Act 2007. The actual rates used are pronounced on the attached Schedule of Fixed Assets and Depreciation.

Derecognition

An item of Plant and Equipment is derecognised upon disposal or when no further future economic benefits are expected from its use or disposal.

(h) Revenue

Entry and Registration Fees collected are accounted for on an accrual basis.

Donations Received are accounted for on a cash basis.

Grants Income is amortised over the term of the agreement, once all obligations pertaining to the advances have been fulfilled. The unexpired portion of any Grants Income at balance date is classified as Revenue in Advance and included in the Statement of Financial Position under Current Liabilities.

Interest Income is recognised when the deposit or investment has matured and the interest is accrued against the deposit or paid directly into the bank current account.

(i) Operating Leases

Leases under which all of the risks and benefits of ownership are effectively retained by the lessor are classified as operating leases. Operating lease payments are charged as an expense in the Statement of Financial Performance in the periods under which they are incurred.

(j) Investment

Consilium Portfolio is recorded at market value.

5. SECURITIES AND GUARANTEES

The Association operates Current, Online Saver and Term Deposit accounts with the Westpac Bank.

There is no overdraft facility secured on the current account. As at balance date the interest rates for monthly credit balances maintained in the current account are 0.75 % p.a. for balances \$5,000 and over.

The Westpac Online Call Account attracts a current interest rate of 1.45 % p.a. on all balances.

The Westpac Online Bonus Saver Account attracts an initial rate of 0.90 % p.a. and a bonus rate of 2.85% provided no withdrawals are made during the month; representing a potential interest rate return of 3.75% p.a. calculated daily on the full balance.
